# **Invitation for Bids (IFB)**

### Supply, Delivery, and Commissioning of Composting Equipment for Noonu **Atoll Council**

The Noonu Atoll Council invites qualified service providers to participate in supply and delivery of equipment's for Organic waste management Project to implement decentralized food waste composting systems across all inhabited islands within Noonu Atoll.

# 1. Project Overview

Objective: To establish sustainable community composting systems based on the Takakura method, which is a low-tech, low-labor, cost-effective urban composting models appropriate for small island communities. This initiative will support waste reduction, environmental sustainability, and circular economy principles across the atoll's inhabited islands.


The project aims to create comprehensive composting infrastructure and capacity building programs that will enable island councils to manage organic waste effectively while producing valuable compost for local agricultural activities.

The objective is to establish decentralized food waste composting systems in each island's Waste Management Centre (WMC) through the supply of standardized composting equipment.

## 2. Scope of Supply & Minimum Specifications (with Quantities)

Bidders must quote for the entire lot (all items). Equivalent or superior specifications may be offered with clear evidence.

# 3. Logistics Delivery & Commissioning

- Delivery Location: Noonu Atoll Council Secretariat, Manadhoo (central hub).
- Installation & commissioning will be supervised jointly by project consultants and WMC staff of each island (coordination provided by the Atoll Council).
- Machinery user manuals shall be provided.
- Provide on-site operator orientation for safe use and routine care (in coordination with project consultants).
- Bidders offering shorter delivery times will receive proportionally higher scores.

### 4. Evaluation Criteria

### **Submission of Bids**

#### **Bids must include:**

- Company profile
- Quotation with itemized unit prices, total price, delivery and clearance price, and warranty terms.
- **Delivery timeline** (from award to delivery at Manadhoo hub).

### **Required Documents;**

The proposal package must include:

- A detailed proposal and price quotation. Equipment specifications and descriptions.
- Warranty: Minimum 12 months on motors and parts.
- Bidders must provide proof of authorization from the manufacturer or evidence of being a verified distributor, importer, or reseller of the offered equipment in the Maldives. Acceptable documents include:
  - o Authorization letter from manufacturer or national distributor
  - o Import registration/licensing where applicable
- Compliance with **Maldivian import regulations** and applicable certifications.

### **Proposal Submission**

Interested parties must register their Expression of Interest via this <u>registration link</u>. Registration closes on 21<sup>st</sup> October 2025. Queries shall be forwarded to hello@noonunaturally.com, all registered parties will receive details of queries and responses.
